TO: ALL IMPORTERS, EXPORTERS AND CUSTOMS CLEARANCE AGENTS (BROKERS)

SUBJECT: TAX IDENTIFICATION NUMBERS (TIN) AND CUSTOMS CLIENT NUMBERS (CCN)

ALL IMPORTERS, EXPORTERS AND CUSTOMS CLEARANCE AGENTS (BROKERS) SHOULD NOTE THAT FOLLOWING THE INTRODUCTION OF THE ASYCUDA WORLD SYSTEM FOR DECLARATION PROCESSING – CURRENTLY ANTICIPATED TO BE ON OR ABOUT 1ST JUNE 2015 – THE CUSTOMS CLIENT NUMBER (CCN) CURRENTLY USED TO FACILITATE THE PROCESSING OF CUSTOMS DECLARATIONS IN PC TRADE WILL NO LONGER BE USED.

REGULAR IMPORTERS AND EXPORTERS, TOGETHER WITH ALL CUSTOMS CLEARANCE AGENTS WILL, FROM THAT DATE, BE REQUIRED TO BE REGISTERED WITH THE INLAND REVENUE DEPARTMENT AND BE IN POSSESSION OF A TIN FOR THE PROCESSING OF DECLARATIONS IN THE ASYCUDA WORLD SYSTEM.

OCCASIONAL CONSIGNEES (AND OCCASIONAL CONSIGNORS) – I.E. THOSE PROCESSING THREE OR LESS DECLARATIONS PER ANNUM – WILL UTILIZE A SPECIFIC CODE ON THE SINGLE ADMINISTRATIVE DOCUMENT (SAD) TO PROCESS THEIR CONSIGNMENTS.

AS THERE ARE OVER 800 DECLARANTS IN THIS CATEGORY IT WILL NOT BE POSSIBLE FOR THE CUSTOMS DIVISION TO PROVIDE TRAINING TO ALL IN THE USE OF THE ASYCUDA WORLD SYSTEM. ACCORDINGLY, IT IS **STRONGLY RECOMMENDED** THAT OCCASIONAL CONSIGNEES AND CONSIGNORS AVAIL THEMSELVES OF THE SERVICES OF A LICENSED CUSTOMS CLEARANCE AGENT TO ASSIST THEM IN PROCESSING THEIR CUSTOMS DECLARATIONS IN THE NEW SYSTEM. A LIST OF CUSTOMS BROKERS LICENSED TO CONDUCT BUSINESS WITH THE CUSTOMS DIVISION IN 2015, TOGETHER WITH THEIR CONTACT DETAILS, IS ATTACHED TO THIS PUBLIC NOTICE FOR INFORMATION.
